## • LISA UPDATE (SB & AL):

- Clubs operating under Phase #1 restrictions and most looking to end season prior to spring break
- LISA had circulated a "Spring League" Interest Survey
   Responses were clear that club membership were interested in some form of Spring programing



- oDiscussion with Technical Directors outlined challenges faced by clubs with lack of fields, resources, qualified coaches, and general feeling of fatigue
- All clubs were planning on operating in-house programing dependent on Provincial Health Restrictions
- Tier 2 Planning group has met and drafted a discussion document
  - Will meet again and finalize draft for circulation ahead of planned interlock in April
  - oSFFC have requested a member be added to represent their club within this group
- Clubs moving ahead with CSA Quality Standards program
  - Quality Sport Hub operating system becoming available to clubs going through the CSA Quality Standards program
- Andrew spoke with BCSA regarding Coach Education
   Courses will remain online for the foreseeable future
