# LISA UPDATE (SB):

• End of the coastal season with District Cup finals hosted by JDF this upcoming weekend

- U13 Full field festival will go ahead this upcoming weekend. Fields and referees have been sorted after the cancelation last weekend.
- Provided update to the INclusion Incorporated- Equity, Diversity, and Inclusion proposal
- Met with Andrea Carey to go over the scope of the project and next steps for presentation to clubs.
  - Andrea will attend the Interlock meeting to provide information and timelines for the implementation of the proposal
  - Next step is presenting the proposal to the clubs at next Interlock meeting

# **BUDGET AND FINANCIALS (SB)**

- Clubs being billed for final season registration databases
- Overall registration up from last year nearly 600 players from last season
- Will present the proposed 2023/2024 Annual Budget for approval at next board meeting

# **COMMITTEE UPDATES**

- Membership Review Committee
  - MRC Chair Howard McElderry provided an overview of the written analysis of the PACE application
  - Draft "Board Decision Letter" was also circulated
    - Discussion was had regarding the member application process and recommendation

**On a Motion duly made, Seconded and Carried** it was resolved that the PACE Sports Association full membership application be denied, based on the analysis and recommendations provided by the MRC.

**On a Motion duly made, Seconded and Carried** it was resolved that the Full Membership Application Form be updated to include an application fee to align with the affiliate membership application process. This fee is non-refundable and will not be applied as a credit to future payments.

  - Festival taking place April 7<sup>th</sup> and 8<sup>th</sup>
