LISA UPDATE (SB):



- Halfway through the Tier 2 season. Things are going well
- Started planning key dates for the 2023/24 season.
 - o JDF planning on Mini-Fest and District Cup Again
 - Looking at U13 Festival post Spring Break
- Meeting with JP Media Group regarding Summer Social Media and Radio Ad Campaigns

GREEN ARMBAND INITIATIVE (AL MOIR)

- Goal is to add another layer to protect young officials from verbal abuse and harassment
 - Initiative is complementary to our Referee recruitment and retention strategy
 - Focuses on grassroots officials and builds off of the signage campaign from last season
- Green armband initiative started in Baseball and was successfully adopted by Hockey organizations in Ontario
 - LISA would be the first Soccer organization to adopt the initiative
- Approach:
 - All Referees under the age of 16 will wear the armband to signify they are a youth official
 - The armband will serve as a reminder of LISA's zero tolerance for referee abuse
- Discipline
 - If a coach gets thrown out from a game for foul and abusive language directed at a youth referee, they will receive a significant suspension as per the BCSA Judicial Policy
 - As well, it is recommended the home Club to add supplemental discipline where necessary
- Implantation of initiative September, 2023
 - Al to meet with Clubs during pre-season follow ups
- A youth official may continue to wear the armband until they turn 18 if they feel comfortable
- Costs being priced out but expect approximately \$10/armband x 200 officials, plus addition information boards at \$20 per information board x50 boards.



On a Motion duly made, Seconded and Carried it was resolved to submit the initiative to the clubs for review and implement the green armband initiative for September 2023

COMMITTEE UPDATES (SB)

- Diversity, Equity, and Inclusion
 - Held introductory meeting with good discussion
 - Committee to reconvene with support from INclusion INcorporated to lay groundwork for committee plan.
- Governance Committee
 - Have reached out to clubs for additional members to committee
 - Stuart and Howard working with Ann Moskow to codify operational policy document.
 - Next task will be LISA Rules and Regulations document.
- Scholarship Committee
 - LISA received 30 scholarships applications
 - 8 Winners to be selected

OTHER BUSINESS

- VISL Correspondence
 - A letter has been submitted to the VISL board requesting an SGM, Board resignations, and complete operational review
 - o LISA was unaware of the letter prior to release
 - No additional comments at this time
- BCSPL
 - VI Wave raising issues with BCSPL
 - BC Soccer is now responsible for running BCSPL.
 - Inconsistent scheduling and score recording have been an issue this season. VI Wave teams have been scheduled one less game weekend compared to other organizations.
